Neither the Provider nor anyone on the Provider's behalf has made any representations to the undersigned as to the safety of said advice or suggestions or as to the undersigned's ability to safely execute said advice or suggestions.

**2. Understanding of Life Coaching:** The undersigned participant understands that Life Coaching is not counseling or professional therapy. The focus of Life Coaching is determined by the participant and focuses on strategic planning, values clarification, building trust and motivational goal setting to achieve the participants identified desired goals. The Provider, Brian Fowler, is not certified as a Life Coach and does not hold a professional degree and offers his Life Coaching from life experiences and insight he has gained over many decades. The Provider is not acting as a mental health provider, psychologist or professional mental health counselor, licensed or otherwise, but rather is acting in the capacity of a non-professional mentor/life coach providing non-professional advice, general guidance and suggestions for the achievement of life goals. If professional therapy, medical or mental health services are needed, the participant assumes responsibility for finding those services elsewhere.

**4. Confidentiality:** As a Life Coach, I am ethically and legally bound to protect the confidentiality of our communications. I will only release information about our work to others with your written permission or in response to a court order. There are some situations in which I am legally obligated to breach confidentiality in order to protect you or others from harm. If I have information that indicates that a child, elderly person, or disabled person is being abused, I must report that to the appropriate state agency. If a client is an imminent risk to themself, or makes threats of imminent violence against another, I am required to report and take protective actions. These situations are quite rare in coaching practices. If such a situation occurs in our relationship, I will make every effort to discuss it with you before taking any action.

**5. Liability Release:** The undersigned completely and unconditionally waives, releases, and forever discharges each and all of the following named entities, persons, and parties (herein collectively referenced as the "Releasees") from all claims of liability for each and every injury, harm, damage, and loss of every kind or description (including death) to the undersigned's person or property, directly or indirectly occurring in connection with, resulting from, or arising out of the undersigned's participation in the *Life Coaching Program*, whether caused by negligence or mistake of any of the Releasees, or otherwise:
